**PETITION FOR CANCELLATION**

Vincent A. Scavo, (hereinafter “Petitioner”), is damaged and continues to be damaged by United States Trademark Registration No. 5,882,052 for the word mark “GOLIATH” for “*Furniture*” in Class 20. The registration was granted on October 15, 2019 to Comfort Research, LLC (“Respondent”), which is, upon information and belief, a Michigan Limited Liability Company with its office and principal place of business at 1719 Elizabeth Ave., Grand Rapids, MI 49504. Accordingly, Petitioner hereby petitions to cancel Trademark Registration No. 5,882,052 under 15 U.S.C. 1064 (Section 14 of the Lanham Act) on the grounds of non-use of the mark in commerce, abandonment of the mark, and the belief that Petitioner will be damaged by the continued registration of Trademark Registration No. 5,882,052.

As further grounds for the cancellation, Petitioner alleges as follows:

1. Petitioner is an Indiana-based individual offering an outdoor beach chair designed for large individuals.

2. Petitioner is the owner of Trademark Application Serial Number 90/378,162 (“the ‘162 application”) filed on December 13, 2020 for the word mark “GOLIATH – THE ULTIMATE OUTDOOR CHAIR” for “*Outdoor beach chairs.*” A copy of the application is attached herewith as **Exhibit A**.

3. Upon information and belief, Respondent is the owner of Trademark Registration Number 5,882,052 (“the ‘052 registration”), filed on July 25, 2018 for the word mark “GOLIATH” for “*Furniture.*”

4. Petitioner received a final office action issued by the USPTO on January 12, 2022 for the ‘162 application, wherein the Examining Attorney maintained a refusal under Trademark Act Section 2(d) for allegedly being confusingly similar with the ‘052 registration owned by Respondent.

#### **Count I: Non-Use of the Mark in Commerce**

5. In the ‘052 registration, Respondent alleges that it used the GOLIATH word mark as at least as early as July 25, 2018.

6. On July 25, 2018, a first specimen purporting to show use of the GOLIATH word mark in commerce in connection with the goods listed in the ‘052 registration was submitted alongside the application for the ‘052 registration. A copy of this specimen is attached herewith as **Exhibit B**.

7. On November 20, 2018, an Office Action was mailed rejecting the first specimen submitted on July 25, 2018, noting “[r]egistration is refused because the specimen appears to consist of a digitally altered image or a mock-up of the mark on the goods or their packaging and does not show the applied-for mark in actual use in commerce.”

8. On May 20, 2019, a second specimen was submitted purporting to show use of the GOLIATH word mark in commerce in connection with a “large foam chair” with dimensions listed as 48”L x 48”W x 34”H and weight listed as 31 lbs. A copy of this specimen is attached herewith as **Exhibit C**.

9. Upon information and belief, the second specimen submitted is merely a cropped version of the first specimen submitted and therefore also constitutes a digitally altered image or a mock-up of the mark on the goods or their packaging and does not show the applied-for mark in actual use in commerce.

10. Under TMEP 904.04(a)(iii), the second specimen should have been refused under the same rationale as the first specimen, as the second specimen does not show actual use of the mark in commerce in connection with designated class of goods.

11. There is no evidence that Respondent used the GOLIATH mark in connection with the registered class of goods prior to the date of filing of the ‘052 registration on July 25, 2018.

### **Count II: Abandonment of the Mark**

12. Upon information and belief, Respondent does not utilize the term “GOLIATH” in connection with the services in the ‘052 registration in commerce, nor does it currently maintain a website that utilizes the term “GOLIATH.”

13. Upon information and belief, Respondent currently maintains a website at [comfortresearch.com](http://comfortresearch.com) and offers a variety of bean bag products through [buybigjoe.com](http://buybigjoe.com).

14. Upon information and belief, neither [comfortresearch.com](http://comfortresearch.com) nor [buybigjoe.com](http://buybigjoe.com) utilize the term “GOLIATH” in reference to any offered products or services as of March 28, 2022.

15. As of March 28, 2022, buybigjoe.com offers a foam chair known as “Big Joe Inspirational Fuf Large” with dimensions listed as 48”L x 48”W x 34”H and weighing 31 lbs. A copy of a webpage showing this item is attached herewith as **Exhibit D**.
16. As of November 1, 2020, buybigjoe.com was offering a foam chair known as “Fuf Large” with dimensions listed as 48”L x 48”W x 34”H, weighing 31 lbs, and having a removable cover. A copy of a Wayback Machine-generated webpage showing this item is attached herewith as **Exhibit E**.
17. The 2018 Big Joe Product Guide lists a foam chair known as “Large Fuf” with dimensions listed as 48”L x 48”W x 34”H and weighing 31 lbs. The 2018 Big Joe Product Guide is attached herewith as **Exhibit F**. The 2018 Big Joe Product Guide does not use the “GOLIATH” mark.
18. A “Fun Book,” which provides information regarding Creative Research LLC and its Big Joe brand, includes an image of a woman jumping onto a foam chair. This image is attached herewith as **Exhibit G**.
19. The image shown in Exhibit G is labeled as “Big Joe Large Fuf in Cobalt Denim Lenox,” with no reference to the GOLIATH mark.
20. Upon information and belief, the image shown in Exhibit G is a digital markup of the image shown in the Second Specimen which has been altered with digital color changes applied to various sections of the Second Specimen.
21. As of March 28, 2022, buybigjoe.com offers a foam chair known as “Big Joe Fuf Large w/Removable Cover” with dimensions 38”W x 49”D x 38”H and weighing 33.25 lb. A copy of a webpage showing this item is attached herewith as **Exhibit H**.

22. As of March 28, 2022, a search for the term “GOLIATH” on the website buybigjoe.com yields zero results. A copy of a webpage showing these results is attached herewith as

**Exhibit I.**

23. Upon information and belief, based on the specimens submitted and the products previously and currently offered by Respondent through its Big Joe brand, the GOLIATH word mark was only ever used in concept drawings for a product previously known as the “Large Fuf” or “Fuf – Large” and now referred to as “Inspirational Fuf Large.”

24. Upon information and belief, no product associated with the word mark “GOLIATH” has ever been sold on buybigjoe.com nor on comfortresearch.com, and more particularly, no product associated with the word mark “GOLIATH” has been sold in the past two years.

25. Upon information and belief, Respondent has ceased using the ‘052 registration, with an intent not to resume use of the ‘052 registration in connection with furniture.

26. Upon information and belief, no furniture associated with the word mark “GOLIATH” has been sold by Respondent within the past three years, thereby constituting prima facie evidence of abandonment of the ‘052 registration.

27. Petitioner believes it is being, and will continue to be, damaged by the continued registration of Trademark Registration No. 5,882,052 for the mark GOLIATH.

WHEREFORE, as Petitioner has been damaged, continues to be damaged and will be damaged in the future by the challenged registration, Petitioner respectfully requests that this registration be canceled on the grounds of Respondent’s abandonment of the mark.

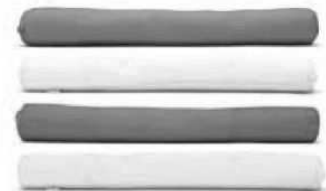
