PETITION FOR CANCELLATION

Petitioner Engage Health, Inc. (“**Petitioner**”), a Minnesota corporation with offices at 3265 Lexington Avenue South, Eagan, Minnesota 55121, believes that it is being and will be damaged

by the continued registration of the mark  engage
by Greenwich Biosciences on the Principal Register and hereby petitions to cancel the same. As grounds for its Petition for Cancellation, Petitioner alleges as follows:

FACTUAL BACKGROUND

Petitioner’s ENGAGE Marks

1. Petitioner is an innovative and experienced health research firm serving the pharmaceutical, biotechnology, and medical device sectors in the commercialization of medical

products, offering a variety of health research and related services under the marks ENGAGE,






(“**ENGAGE & Design Mark**”), and ENGAGE HEALTH, among others.

2. Since at least as early as September 2001, Petitioner has continuously used marks comprising or containing the mark ENGAGE in connection with health research services, consulting services in the fields of pharmaceutical, biotechnology, and medical products and services, business advice and analysis of markets, business meeting planning, market analysis, market assessment services, market research, market research consultation, product development consultation, product research and development, and patient recruitment and retention services for clinical studies conducted by others, patient and caregiver identification and mapping, and other services (collectively, “**Petitioner ENGAGE Marks**” and “**Petitioner’s Services**”).

3. In connection with Petitioner’s ENGAGE Marks for Petitioner Services, Petitioner owns the following valid and subsisting trademark applications and registrations, among others, at the United States Patent and Trademark Office (“**USPTO**”):

(collectively, “**Petitioner’s Registrations and Applications**”). *See* Exhibit A, TSDR Printouts for the above-identified Petitioner’s Registrations and Applications.

4. The validity of Petitioner’s Registration Nos. 2,856,390, 4,267,458, and 4,267,459, and Petitioner’s ENGAGE Marks that are the subject thereof, and Petitioner’s exclusive right to use those marks in commerce, are incontestable pursuant to 15 U.S.C. §§ 1065 and 1115(b), as the required affidavits have been filed and accepted by the USPTO. *See* Exhibit A.

5. The dominant portion of each of Petitioner’s ENGAGE Marks is the word “engage.”

6. Petitioner’s ENGAGE & Design Mark consists of an arch made up of geometric shapes cradling the first part of the word “engage.”

7. As a result of the extensive sales and promotion of Petitioner’s Services under Petitioner’s ENGAGE Marks, Petitioner has built up highly valuable goodwill in Petitioner’s ENGAGE Marks that is closely and uniquely identified and associated with Petitioner.

Registrant’s Mark

8. Despite Petitioner’s longstanding common law of use of Petitioner’s ENGAGE Marks and multiple of Petitioner’s Registrations having already issued, on December 12, 2018, GW Research Limited (“**Registrant**”) filed U.S. Trademark Application Serial No. 88/226,693



(“**Registrant’s Application**”) for the mark (“**Registrant’s Mark**”),

which ultimately matured into U.S. Registration No. 6,295,784 (the “**Contested Registration**”)

on the Principal Register, on March 16, 2021, covering the following goods and services:

Class 16: printed matter, namely, books, magazines, posters, leaflets, manuals, and instructional and teaching materials, in the field of medical disorders and conditions, medical treatments and equipment, pharmaceutical preparations and dosing and administering of medication;

Class 36: Medical and health care insurance services, namely, medical and health care insurance information, consultancy, administration, brokerage, underwriting, providing information about healthcare insurance plans; savings account services relating to medical and health care insurance; financial administration of patient reimbursement programs; insurance services, namely, insurance eligibility review and verification and consultation related to medical and health care insurance; providing information about medical and healthcare insurance plans; providing information, advisory and consultancy services relating to the aforesaid services; and

Class 44: providing medical support, namely, providing an internet website for medical professionals, caregivers, and patients featuring medical information; provision of information and advice relating to medical disorders and conditions, medical treatments and pharmaceutical preparations; provision of information and advice relating to the dosing and administering of medication; provision of information and advice relating to medical equipment; providing information, advisory and consultancy services relating to the aforesaid services

(“**Registrant’s Goods and Services**”). Attached as Exhibit B is the TSDR printout for the Contested Registration.

9. Like each of Petitioner’s ENGAGE Marks, the dominant portion of Registrant’s Marks is the word “engage.”

10. Like each of Petitioner’s ENGAGE & Design Marks, Registrant’s Mark also contains an arch made up of geometric shapes cradling the first part of the word “engage.”

COUNT I: PRIORITY OF USE AND LIKELIHOOD OF CONFUSION

11. Petitioner hereby incorporates by reference the allegations in Paragraphs 1-10 as if fully set forth herein.

12. Petitioner has priority in use, filing date, and/or registration over the Contested Registration. In particular, Petitioner first used the earliest iterations of Petitioner's ENGAGE Marks in connection with various services at least as early as 2001, including but not limited to first using Petitioner's ENGAGE & Design Marks in Classes 35, 42, 44, and 45 since at least as early as July 2003.

13. Registrant applied for the Contested Registration on December 12, 2018, more than fifteen years after Petitioner first used Petitioner's ENGAGE Marks with Petitioner's Services. Upon information and belief, Registrant did not use Registrant's Mark in commerce for any services, including but not limited to the services covered by the Contested Registration, prior to December 12, 2018.

14. The word "engage" in Registrant's Mark is exactly the same in sight, sound, and meaning as the word "engage" in Petitioner's ENGAGE Marks.

15. Registrant's Mark depicts the word "engage" above the words "by Greenwich Biosciences."

16. Registrant's Mark depicts the word "engage" in larger font size than the words "by Greenwich Biosciences."



17. Registrant's Mark depicts the word "engage" with different capitalization and stylization than the words "by Greenwich Biosciences."

18. The dominate word in Registrant's Mark is "engage."

19. The dominant portion of Petitioner’s ENGAGE Marks and Registrant’s Mark is the same word “engage.”

20. The overall commercial impression of Petitioner’s ENGAGE Marks and Registrant’s Mark is the same because the dominant portion of the marks is the same.

21. The overall commercial impression of Petitioner’s ENGAGE & Design Mark and Registrant’s Mark is the same because both marks consist of an arch made up of geometric shapes cradling the first part of the overlapping dominant word “engage,” as shown below:

22. Registrant’s Goods and Services are identical to, closely related to, overlap with, and/or are of the type that comes from the same source as, Petitioner’s Services.

23. The Contested Registration is not limited to any particular channels of trade.

24. On information and belief, Registrant markets and sells Registrant’s Goods and Services under Registrant’s Mark through channels of trademark the same or similar to those through which Petitioner markets and sells Petitioner’s Services under Petitioner’s ENGAGE Marks.

25. The Contested Registration is not limited to any particular class of consumers.

26. On information and belief, Registrant markets and sells Registrant’s Goods and Services under Registrant’s Mark to the same or similar class of consumers as those to whom Petitioner markets and sells Petitioner’s Services under Petitioner’s ENGAGE Marks.

27. Registrant's Mark so resembles Petitioner's Mark as to be likely, when used in connection with Registrant's Goods and Services, to cause confusion, to cause mistake, and to deceive consumers who are likely to believe that Registrant's Goods and Services have their origin with Petitioner and/or are approved, endorsed, or sponsored by Petitioner, or associated in some way with Petitioner.

28. Petitioner is being and would be injured by the continued registration of Registrant's Mark because of a likelihood of consumer confusion.

CONCLUSION

29. For all of the foregoing reasons, Petitioner has been and will continue to be irreparably harmed by the Contested Registration.

WHEREFORE, Petitioner respectfully prays that the Trademark Trial and Appeal Board sustain its Petition for Cancellation and cancel the registration of the mark shown in Registration No. 6,295,784 with prejudice.
