**PETITIONERS’ RESPONSE TO RESPONDENT’S MOTION TO DISMISS
PETITIONERS’ PETITION TO CANCEL RESPONDENT’S LIGHT STREET
REGISTRATION**

Petitioners Light Street Ventures LLC, Light Street Capital Management LLC, and Light Street Investments LLC (collectively “Petitioners”) respectfully submit this Memorandum in Opposition to Respondent Light Street Capital Management, LLC’s (“Respondent”) Motion to Dismiss pursuant to Fed. R. Civ. P. 12(b)(6). As shown below, Petitioners’ Petition for Cancellation states plausible claims for relief, and disposition on a motion to dismiss is entirely inappropriate here. Petitioners respectfully submit that the Board should deny Respondent’s Motion to Dismiss.

I. Legal Standard

To overcome a motion to dismiss, the claimant need only allege “enough facts to state a claim to relief that is plausible on its face.” *Bell Atl. Corp. v. Twombly*, 550 U.S. 544, 547, 127 S. Ct. 1955, 1960 (2007). A claim need not contain detailed factual allegations. *Id.* at 1964-65. A claim is sufficiently plausible where “the plaintiff pleads factual content that allows the court to draw

the *reasonable inference* that the defendant is liable for the misconduct alleged.” *Ashcroft v. Iqbal*, 556 U.S. 662, 678 129 S.Ct. 1937, 1949 (2009) (citing *Twombly*, 550 U.S. at 556) (emphasis added). Here, the complaint provides enough information to allow the TTAB to reasonably draw the inference that Petitioners will be harmed by the continued registration of Respondent’s trademark based on the facts alleged. Respondent has the burden to show that Petitioners’ claim should fail as a matter of law. Respondent has not satisfied this burden, instead relying on faulty factual arguments concerning priority of use and an incomplete factual analysis of the issues in the present case – none of which can support a motion to dismiss.

II. Respondent Has Not Met Its Burden to Dismiss As a Matter of Law Concerning Any Alleged Priority of Use

The crux of Respondent’s argument hinges on their factual assertions that they acquired a priority of use over Petitioners. As purported evidence, they include Respondent’s TSDR entry listing a first use date of 2010. Respondent includes nothing further to show a first use consistent with that date. This is all inappropriate for a Fed. R. Civ. P. 12(b)(6) motion to dismiss, as Respondent is not carrying its burden to show that Petitioners’ Petition is insufficient, but is arguing evidence – and inadequately so. Even when the evidentiary phase of this matter is reached, without additional evidence supporting a first use in commerce, “the earliest date of use to which respondent is entitled... is the filing date of the application.” *Jay-Zee Inc. v. Hartfield-Zody’s, Inc.*, 207 U.S.P.Q. 269, 272 (TTAB 1980); *see also L. & J.G. Stickley, Inc. v. Cossar*, 81 U.S.P.Q.2d 1956 (T.T.A.B. 2007); *and Safe-T Pacific Co. v. Nabisco, Inc.*, 204 U.S.P.Q. 307 (TTAB 1979).

Indeed, a cursory review of Respondent’s TSDR entry demonstrates that there is nothing, outside of a statement from Respondent’s Chief Financial Officer, that should lead to a presumption that 2010 is in fact the first use of Respondent’s trademark. On the contrary, the specimens submitted in Respondent’s trademark application all list February 2016 as the date used.

Therefore, the first use that Respondent is entitled to is the filing date of the application, which is July 2016. This first use occurred *after* Petitioners began using LIGHT STREET in commerce in 2015. Even if we went with the earliest evidence in Respondent's TSDR entry, the specimens listing a date of February 2016, this use would still occur after Petitioners' first use of LIGHT STREET. But it is important, indeed critical to note, that these evidentiary or factual arguments *are not the province of a Fed. R. Civ. P. 12(b)(6) motion to dismiss, which is not a vehicle to adjudicate factual disputes.*

Arguing factual issues as they are, the entire basis for Respondent's Motion to Dismiss falls apart. The only case law Respondent cites discusses the need to consider priority of use when analyzing likelihood of confusion. Respondent's Motion contains no further discussion of whether there is a likelihood of confusion nor any other defenses against Petitioners' claims. Respondent has done nothing to carry their burden that Petitioners' claims should fail as a matter of law on a Fed. R. Civ. P. 12(b)(6) motion.

III. Respondent's Motion to Dismiss Relies on an Incomplete Analysis of Trademark Law

Compounding their inappropriate factual arguments that have no place in a motion to dismiss, Respondent's Motion also ignores critical aspects of trademark law that will defeat their factual arguments in this case. Assuming, *arguendo*, that Respondent is correct in their factual allegations (which Petitioners strongly contend otherwise), their evaluation is not complete. Courts have recognized an additional analysis regarding priority of use and whether a trademark is worthy of nationwide protection. Such further analysis demands denial of a motion to dismiss.

The *Noah's Inc.* case tells us that even if a registered user began using the trademark earlier than another party, "a senior party may abandon its right as a prior user to... enjoy nationwide protection of its mark." *Noah's, Inc. v. Nark, Inc.*, 560 F. Supp. 1253, 1259 (E.D. Mo. 1983)

(holding that a senior registered user abandoned its right to enjoy nationwide protection of its mark by participating in “little to no expansionist activities” in other states and granting the junior user nationwide trademark protection because they demonstrated substantial attempts and activities to expand). As this case proceeds, the evidence will show that just as in the *Noah’s Inc.* case, Respondent has not attempted to enjoy nationwide protection of its mark. Respondent has two offices, both located in the San Francisco Bay Area; one in San Francisco, California and one in Palo Alto, California. The TTAB can take judicial notice that the distance between these two offices is only approximately thirty-three and a half (33.5) miles. A Google Maps listing evidencing this distance is attached as **Exhibit A**. On information and belief, Respondent has not filed as a foreign corporation nor any other type of incorporation in a state other than California, nor have they established partnerships or subsidiaries in other states, and the TTAB can take judicial notice of the public record that is bereft of the same. Respondent’s activities have thus been confined to the Bay Area, just as Noah’s Inc. confined its business practices to the Iowa market. *Id.* At 1259-60.

Meanwhile, Petitioners have demonstrated substantial attempts to expand as evidenced through incorporation in both Illinois and Nevada, evidence of which is attached and incorporated herein as **Exhibit B** of which the TTAB also can take judicial notice. Additionally, as this case proceeds, Petitioners will adduce evidence that they have utilized the LIGHT STREET mark in various business activities and partnerships across the country. This is similar to the “substantial activities” of Nark Inc. who advertised and franchised in other states. *Noah’s Inc.*, 560 F. Supp. at 1260. If Nark Inc.’s activities were sufficient to grant them priority of use as the junior user, then Petitioners’ similar actions should be given the same treatment. Because of this, there will be evidence presented that it is the Petitioners, *not* Respondent, that should have priority of use,

making Respondent's arguments entirely inappropriate for a motion to dismiss. At the very least, Respondent cannot carry its burden that Petitioners' claims should fail as a matter of law on a Fed. R. Civ. P 12(b)(6) motion.

IV. CONCLUSION

Respondent has failed to carry the very high burden of a movant under Fed. R. Civ. P. 12(b)(6) to show that Petitioners' Petition has no plausible claim for relief. On closer examination, Respondent relies on disputed factual issues as to priority of use that cannot be determined on a motion to dismiss. What is more, Respondent ignores substantial other issues (outlined in Section III above) that will support Petitioners' relief over Respondent's protestations. On this record, the TTAB must deny Respondent's motion to dismiss and allow this matter to proceed.

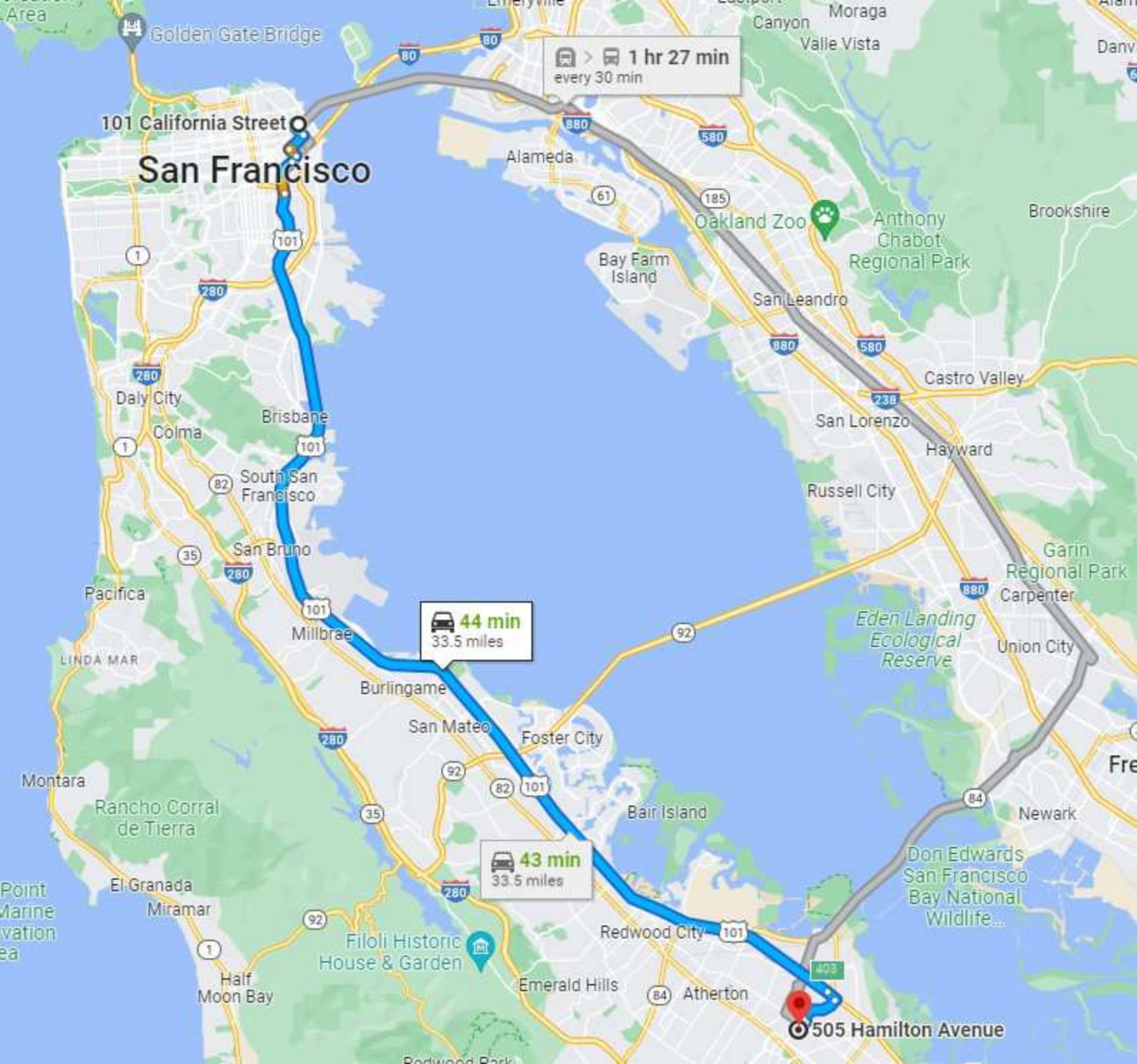
