REGISTRANT’S MOTION TO SUBSTITUTE

Delicato Vineyards, LLC, a Delaware limited liability company, hereby moves to substitute itself in place of Delicato Vineyards, a California corporation, as Registrant in this proceeding. Touchstone Cellars, LLC (“Petitioner”) filed its Petition for Cancellation of U.S. reg. no. 6,201,352 for BOLD WINE FOR A REBELLIOUS TIME (the “Registration”) with the Trademark Trial & Appeal Board on June 30, 2022 (the “Proceeding”). 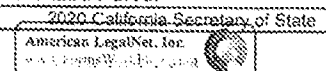
