Respondent’s registration is for the styled form of the words WE GOT YOUR SIX SUPPORTING OUR NATION'SVETERANS in Class 35 for “Promoting public awareness of the interests of veterans with ptsd.” The mark registered on March 27, 2018.

As grounds for this Petition, Petitioner alleges that:

1. Petitioner is informed and believes and thereon alleges that Respondent has abandoned said registered mark by discontinuing its use with no intent to resume its use. Petitioner will be impaired by the continued registration of said abandoned mark of Respondent, since its continued existence on the Principal Register will prevent Petitioner from registering its marks.
2. Petitioner has made attempts to contact Respondent directly without any response, and therefore is further informed and believes that Respondent has abandoned said mark.

WHEREFORE, Petitioner prays that Registration No. 5431237 be cancelled and Petitioner respectfully requests that this Petition for Cancellation be sustained in favor of Petitioner.
