SECOND CONSENT MOTION TO SUSPEND

Pursuant to 37 C.F.R. § 2.117(c) and TBMP § 510.03(a), Respondent Bob Drake Reproductions, Inc. (“Respondent”) hereby moves for further suspension of this proceeding for purposes of settlement negotiations, subject to the right of either party to request resumption at any time.

Accordingly, Respondent respectfully requests the Board grant this Motion and suspend the cancellation proceeding for settlement negotiations.
