PETITION FOR CANCELLATION

The Petitioner, Idexo Holding B.V., a NETHERLANDS corporation with an address of Flight Forum 810, Eindhoven, NETHERLANDS 5657DV (hereinafter “Petitioner”), files this Petition for Cancellation against Evercommerce Solutions, Inc. (hereinafter “Respondent”), and believes that it is and will be continued to be damaged by the registration of the above-identified Reg. No. 3765354 of ACCEPTPAY in International Class 036 and hereby seeks to cancel same, pursuant to 15 U.S.C. § 1064 and 37 C.F.R. § 2.111.

As grounds for cancellation, it is alleged that:

1. Petitioner is the owner of U.S. Appl. No. 90154235 of PAYACCEPT for the following services in International Class 036 filed on September 3, 2020:

Financial services, namely, electronic funds transfer; clearing and reconciling financial transactions via a global computer network and wireless networks; providing electronic mobile payment services for others in the nature of providing secure commercial transactions and payment options using a mobile device at a point of sale; credit card transaction processing services and payment processing services in the field of credit card payments and electronic payments; payment processing services, namely, providing virtual currency transaction processing services for others; all of the foregoing services provided solely in connection with cryptocurrencies and crypto assets using blockchain-based technology


(hereinafter “Petitioner’s ‘235 Mark”), a status copy of which is annexed hereto and incorporated herein as **Exhibit 1**.

2. Upon information and belief, Respondent is the owner of Reg. No. 3765354 of ACCEPTPAY for “electronic payment, namely, electronic processing and transmission of bill payment data; Providing electronic processing of credit card transactions and electronic payments via a global computer network” in International Class 036 with a registration date of March 23, 2010 (hereinafter “Respondent’s ‘354 Mark”), a status copy of which is annexed hereto and incorporated herein as **Exhibit 2**.
3. On January 30, 2023, the Examining Attorney assigned to Petitioner’s ‘235 Mark issued a final refusal to register on the grounds of likelihood of confusion with Respondent’s ‘354 Mark under Section 2(d) of the Trademark Act.
4. Upon information and belief, and based on the results of an independent, third-party marketplace investigation undertaken on Petitioner’s behalf, it has been concluded that Respondent has not used its ACCEPTPAY Mark on or in connection with any and/or all of the services set forth in Reg No. 3765354 of ACCEPTPAY for at least three-consecutive years prior to the filing of this Petition for Cancellation.
5. Upon information and belief, and based on the results of an independent, third-party marketplace investigation undertaken on Petitioner’s behalf, Respondent did not have an objective, *bona fide* intent to resume use of its ACCEPTPAY Mark on or in connection with any and/or all of the services set forth in Reg. No. 3765354 of ACCEPTPAY as of the date of the filing of this Petition for Cancellation.
6. Upon information and belief, Petitioner has abandoned Reg. No. 3765354 of ACCEPTPAY pursuant to 15 U.S.C. §1064(3).

7. The continued maintenance of Respondent's Reg. No. 3765354 of ACCEPTPAY has caused, and will continue to cause irreparable harm, injury, and damage to Petitioner.

WHEREFORE, Petitioner respectfully requests that Reg. No. 3765354 of ACCEPTPAY be cancelled and that judgment issue in favor of Petitioner.
