**PETITION TO CANCEL**

Petitioner Ox Paha Inc. (“Petitioner” or “Ox Paha”), a corporation organized under the laws of the State of California, with its principal place of business at 8025 Melrose Ave., Los Angeles, CA 90046 believes that it has and will continue to be damaged by registration of the YE (stylized) mark in Registration No. 6,118,116 (Respondent’s Mark) and hereby petitions to cancel the same.

Petitioner hereby petitions for cancellation of same pursuant to Section 14(1) and 2(d), Section 14(3), and Section 2(c) of the Lanham Act of 1946 (“Lanham Act”). 15 U.S.C. Section 1064(1).

As grounds for cancellation, Petitioner alleges as follows:

1. Ox Paha is a corporation owned by the internationally renowned Grammy® Award-winning musical artist, performer, media company owner, songwriter, producer, film director and fashion designer YE formally known as Kanye West (“West”).

2. West first rose to fame as a producer for Roc-A-Fella Records, where he achieved recognition in 2001 for his work on Jay Z's album *The Blueprint*, as well as on hit singles for musical artists including Alicia Keys, Ludacris and Janet Jackson. To date, West has released nine full-length studio albums, has sold over 32 million albums and over 100 million digital songs, making him one of the best-selling artists of all-time. West has adorned the cover of hundreds of magazines, including, but not limited to, *Vogue*, *GQ*, *Time* and *Rolling Stone* magazines. *Time* has ranked West on its list of the 100 Most Influential People, and *Forbes* has identified him on its annual Celebrity 100 list. MTV also honored West with the 2015 Michael Jackson Video Vanguard Award, honoring "his career- spanning groundbreaking videos, legendary VMA performances, and continued impact on music, art, fashion, and culture."
3. West's recognition expands well beyond the world of music. West sets trends for everything he touches. He has launched his own clothing and bag lines, designed products with major athletic apparel companies and even designed high-end shoe lines for Louis Vuitton and Giuseppe Zanotti.
4. Labeled as one of the most acclaimed rappers of the 21st century, West's massive following knows West as "YE," a pseudonym that West adopted in 2018. In 2021 West officially and legally changed his name to YE. The YE mark functions as a source identifying trademarks for goods and services emanating from Petitioner.

Priority and Likelihood of Confusion: Trademark Act Sections 14(1) and 2(d)

5. Petitioner offers for sale and sells various goods under the YE mark including, but not limited to, clothing, sneakers, athletic apparel, caps, coats, pants, t-shirts and socks.

6. The YE mark serves to identify Petitioner as the sole source of high- quality goods bearing the mark, and the mark has become internationally famous and a substantial commercial asset.
7. As a result of its widespread, continuous, and exclusive use of the YE mark to identify its products as their source, Petitioner owns valid and subsisting federal unregistered and common law rights to the YE mark.
8. Petitioner's YE mark is distinctive to both the consuming public and Petitioner's trade.
9. Petitioner has expended substantial time, money, and resources, marketing, advertising, and promoting the products sold under its YE mark including through Petitioner's marketing, advertising and promotional efforts and channels under this mark.
10. The items Petitioner offers under its YE mark are of high quality and widely recognized because of this quality.
11. Petitioner is the owner of a United States trademark registration for the YEEZY mark, Reg. No. 5,125,895, for use in connection with Class 25 "clothing, namely, footwear, shoes, [and] sneakers."
12. Petitioner is the owner of a United States trademark registration for the YZY mark, Reg. No. 5,227,726, for use in connection with Class 25 "footwear."
13. Petitioner's registrations for the YEEZY and YZY marks are valid, subsisting and in full force and effect and serves as evidence of Ox Paha's exclusive right to use the marks in commerce on or in connection with the goods identified in the registrations, as provided by 15 U.S.C. § 1155(a).
14. True and correct copies of the registration certificates for the YEEZY mark, Reg. No. 5,125,895, and YZY mark, Reg. No. 5,227,726, are attached hereto as Exhibit A.

Petitioner hereby gives notice in accordance with Trademark Rules of Practice 2.122(d)(2) that it will rely upon these registrations as evidence in this proceeding, and status copies showing present title may be introduced into evidence on its behalf during the testimony period.

15. Petitioner is the owner of a United States trademark application for YE, Application Serial No. 97/056,475, for use in connection with Class 41 services, namely “Charitable services, namely, academic mentoring of school age children, junior and high school students, providing school supplies to children in need, providing books and musical instruments to those in need, providing resource library services to those in need, award program for major corporations and individuals who have made significant charitable contributions, providing toys and sporting goods to underprivileged and needy children, providing arts and crafts to needy and underprivileged children, providing televisions to those in need; charitable services, namely, vocational guidance and career counseling to indigent persons seeking employment; organizing and conducting entertainment events, namely, musical events in the nature of concerts, sporting events in the nature of triathlons, and culinary events in the nature of cooking competitions, the proceeds of which are donated to charity; entertainment services, namely, providing prerecorded music in the nature of rental of musical recordings that may be downloaded from an Internet web site, information in the field of music, commentary and articles about music, all online via a global computer network; Computer services, namely, providing an online non-downloadable magazine in the fields of music, lifestyle, home and personal fashion, home furnishings and accessories, art, clothing, landscape design, interior design, architecture, flowers, florists, entertainment, restaurants, real estate, and shopping; record production; music production; audio recording and production; videotape production; motion picture song production; production of video discs for others; recording studios;

entertainment services, namely, producing musical audio and video programs;

entertainment services, namely, distribution of musical performance productions and audio radio productions and video programs in the nature of motion picture films; music composition and transcription for others; songwriting services; music publishing services;

entertainment services in the nature of live performances by a musical artist, musical group or musical band; entertainment services in the nature of live visual and audio performances by a musical artist, musical group and musical band; entertainment, namely, live music concerts; entertainment, namely, personal appearances by a musician, musical group, musical band, entertainer, actor or celebrity; entertainment services, namely, providing a web site featuring non-downloadable musical performances, non-downloadable musical videos, nondownloadable related film clips, and non-downloadable photographs; production of television and radio programs; radio entertainment production; motion picture film production; entertainment in the nature of ongoing television, cable television and radio programs featuring music, beauty, fashion, modeling, comedy, dramatic acts, and spoken word; entertainment services, namely, providing television and cable television programs, not downloadable, featuring music, entertainment, fashion, beauty, comedy, drama, dramedy, and spoken word;

Petitioner is the owner of a United States trademark application for YE, Application Serial No. 97/056,481, for use in connection with Class 45 services, namely “Cartoon character licensing services; intellectual property licensing services; Security services for the protection of property and individuals, namely, security threat analysis for protecting personal property and personal safety; personal and social services rendered by others to meet the needs of individuals, namely, personal wardrobe styling services; Personal lifestyle consulting services; Personal fashion consulting services, fashion information services, counseling in the fields of fashion and wardrobe style, counseling in etiquette and protocol, personal lifestyle consulting services and personal image development consultation; Providing an online computer database for integrating and implementing information in the field of personal development, lifestyle choices in the nature of self-improvement, and personal life and time management; Providing information, news and commentary in the field of fashion and self improvement via a global computer network; providing a web site and an interactive web site featuring information in the field of fashion, self improvement and lifestyles, motivational and inspirational messages, and information concerning charitable, philanthropic causes, not-for-profit organizations and humanitarian efforts in the field of social justice; Social services for underserved communities, namely, charitable services in the nature of providing clothing and shoes to needy persons and at-risk populations; Counseling in the field of developing,

strengthening and sustaining well-balanced families and family relationships, namely, charitable outreach services, namely, providing counseling services in the field of family-focused outreach services for infants and toddlers with hearing problems, namely, counseling about improving social skills and interpersonal communication for infants and toddlers with hearing problems; charitable services in the nature of providing free legal services to low-income families; charitable services in the nature of providing free legal counseling in the areas of landlord and tenant housing, child custody/support, domestic violence, divorce, immigration, employment, and in obtaining government benefits and entitlements, public assistance, food stamps, housing, healthcare, school lunch, heating assistance, medicaid and social security disability to low-income families; charitable services, namely, providing emotional support by means of granting wishes of those in need, specifically terminally ill children, impoverished families, and victims of natural disasters; charitable humanitarian services, namely, providing personal companionship in the nature of a visit to individuals in hospitals, clinics, hospices, schools, day care centers, shelters, health care facilities, long term care facilities, and group homes; charitable services, namely, providing an internet website containing motivational and inspirational content, namely, news stories, personal accounts and nonfiction articles, for use by children with serious illness and their family and friends all regarding personal growth; charitable services, namely, providing floral products to the elderly and needy children; Personal development consultation for others in the field of time management, lifestyle management and organizational skills; personal concierge services for the personal and professional use of others comprising lifestyle management, making requested personal arrangements and providing customer specific information to meet

26. The applications referenced in paragraphs 15 through 26 constitute a family of marks.
27. Print outs of the TSDR status pages for the YE marks referenced in paragraphs 15 through 26 are attached hereto as Exhibit B.
28. Petitioner’s YE, YEEZY and YZY marks are inherently distinctive and arbitrary.
29. The registrations for the YEEZY and YZY marks are not limited by channels of trade or by classes of purchasers.
30. Petitioner has developed extensive common law rights in the YEEZY and YZY marks as source identifiers of high-quality products. Goods bearing these marks have been sold throughout the United States since at least as early as February 2015 to the general consuming public through the normal channels of trade for these types of goods.
31. By virtue of widespread sales and advertising and promotion of the goods offered under the YEEZY and YZY marks, Petitioner’s marks have become well-known by the general public and in the relevant industries, is recognized and relied upon as identifying Petitioner’s goods and as distinguishing them from the goods of others and have come to represent and symbolize extremely valuable goodwill belonging exclusively to Petitioner. Petitioner has spent substantial time, effort and money promoting its goods under the YEEZY and YZY marks. Through these efforts, the YEEZY and YZY marks have become famous within the meaning of Section 43(c) of the Lanham Act, as amended 15 U.S.C. § 1125(c).

Abandonment: Trademark Act Section 14(3)

32. Upon information and belief, Respondent, Ping Lin (“Respondent”) is an individual with an address of No. 14\_2, Dayuan Alley, Nanmen Community, Licheng Town, Xianyou County, Fujian, China 351200.
33. Upon information and believe, Respondent is the current listed owner of Registration No. 6,188,116 for the mark YE (stylized) in connection with “Athletic apparel, namely, shirts, pants, jackets, footwear, hats and caps, athletic uniforms; Bathing costumes; Bodices; Bottoms as clothing; Coats for men and women; Footwear; Gym suits; Panties; Pants; Shirts; Socks; T-shirts; Tops as clothing; Trousers; Under garments” (“Registered Goods”) in International Class 25. The trademark registration is based on a Section 1(a) application for the mark YE (stylized) with a claimed date of first use and date of first use in commerce of December 23, 2018.
34. After conducting a diligent investigation, Petitioner can find no evidence that Respondent has sold for several years or is selling products bearing Respondent’s Mark in the United States.
35. A search on Google.com conducted on November 6, 2023 (produced no results of the mark in U.S. commerce in connection with any of the Registered Goods. Exhibit C.
36. A search on Google Images conducted on November 6, 2023 produced no results of the exact mark in U.S. commerce in connection with any of the Registered Goods. Exhibit D.
37. Respondent’s Registration covers apparel and is owned by a foreign registrant. In these circumstances, it is reasonable to expect that if the mark was used in U.S. commerce, Respondent would have an Internet presence and references to Respondent would be

readily found through searches of Internet sources where goods of the type are traditionally sold.

38. Petitioner contends that if Respondent actually ever did use the registered mark in commerce, it discontinued such use of the mark and has no genuine intent to resume use within the United States.

Name of a Living Individual Without Written Consent: Trademark Act Sections 14(1) and 2(c)

1. Respondent's Mark consists of or is comprised of the name of a particular living individual, namely, YE, formerly known as Kanye West, owner of Petitioner, and is filed without consent from the living individual. 15 U.S.C. § 1052(c).

**WHEREFORE**, Petitioner, by its undersigned attorneys, requests that (i) its cancellation of Reg. No. 6,118,116 be granted; and (ii) the Trademark Trial and Appeal Board grant any and all further relief to Ox Paha Inc. that the Board finds necessary and just in the circumstances.

Petitioner appoints as its attorneys in these proceedings Gregory K. Nelson, Weeks Nelson.
