PETITION FOR CANCELLATION

Petitioner State Employees' Credit Union, having an address of 119 N. Salisbury Street, Raleigh, North Carolina 27603, believes that it will be damaged by the continued registration of the above-identified marks and, accordingly, hereby petitions to cancel the same pursuant to the provisions of Section 14 of the Trademark Act of 1946, 15 U.S.C. § 1064, as amended.

As grounds for this petition, Petitioner alleges the following:

1. Petitioner filed the following U.S. applications on April 14, 2023, in connection with certain financial services:

97889244 – SECU STATE EMPLOYEES' CREDIT UNION & Design
97889249 – SECU STATE EMPLOYEES' CREDIT UNION & Design

2. On January 18, 2024, the USPTO issued Office Actions refusing registration of each of the applications listed in paragraph 1 on grounds, *inter alia*, of a likelihood of confusion with the mark in Registration No. 6986857 - SECU FINANCIAL PARTNERS, owned by Respondent State Employees Credit Union of Maryland, Inc., under Section 2(d) of the Lanham Act.

3. Respondent's application which matured into Reg. No. 5797984, Application No. 88124852, was filed on September 20, 2018, and alleged a date of first use and first use in commerce of December 13, 2017.

8. The filing date of the application that matured into Petitioner's Reg. No. 6041539 is earlier than the filing date of Respondent's Reg. No. 6986857.

9. Petitioner has common law rights in the mark SECU for use in connection with banking and financial services, credit union services, and related services and goods, and has used the mark SECU since long prior to November 13, 2017, or any earlier use of Respondent's marks that are the subject of this Petition for Cancellation that Respondent may claim.

10. Petitioner has federal registration and common law priority over Respondent's marks and registrations that are the subject of this Petition for Cancellation.

11. Petitioner intends to continue to file for, and use, other marks that incorporate SECU in connection with banking and financial services, credit union services, and related services and goods. Petitioner is concerned that Respondent's Registration Nos. 5797984 – SECU CAR SHOPPER; 5967964 – SECU Me2You; and 6986857 – SECU FINANCIAL PARTNERS, unless cancelled, will be cited as a bar to those applications.

12. In view of the USPTO's assertion, in the Office Actions issued on January 17 and 18, 2024, in connection with Petitioner's applications identified in paragraphs 1 and 4 above, that there is a likelihood of confusion of those marks incorporating SECU with the marks in Respondent's registrations that are the subject of this Petition for Cancellation, Petitioner is compelled, for purposes of this proceeding, to assert the same herein.

13. Respondent's marks in the registrations that are the subject of this Petition for Cancellation so resemble Petitioner's marks that incorporate or comprise SECU that their use and registration in connection with Respondent's services is likely to cause confusion, or to cause mistake, or to deceive as to the source or origin of Respondent's services, or to cause the public to assume erroneously that Respondent or its services are in some way connected with and/or sponsored by or affiliated with Petitioner, or vice versa, all within the meaning of Section 2(d) of the Trademark Act of 1946, 15 U.S.C. § 1052(d), as amended, and will injure and

damage Petitioner and the goodwill and reputation that has been established in Petitioner's marks that incorporate or comprise SECU.

14. By reason of the foregoing, Petitioner is being damaged by the continued existence of Registration Nos. 5797984 – SECU CAR SHOPPER; 5967964 – SECU Me2You; and 6986857 – SECU FINANCIAL PARTNERS.

WHEREFORE, pursuant to Section 14 of the Trademark Act of 1946, 15 U.S.C. § 1064, as amended, Petitioner requests that this petition be granted, and that Registration Nos. 5797984 – SECU CAR SHOPPER; 5967964 – SECU Me2You; and 6986857 – SECU FINANCIAL PARTNERS be cancelled.
