PETITION FOR CANCELLATION

WE ARE HAPPY, LLC, Delaware limited liability company, having its business address at 154 Highland Avenue, Montclair, New Jersey 07042 (“Petitioner”), through its attorneys, believes that it is being and will be damaged by Brew and Foam South Shore LLC’s (“Registrant”) trademark registration for the mark LET'S GRAB COFFEE (“Registrant’s Mark”), and alleges as follows.

FACTS

1. Petitioner is in the business of designing, producing, marketing and selling coffee; coffee drinks; espresso drinks; espresso; prepared coffee and coffee-based beverages; cold coffee; tea; coffee shots; coffee pods; instant coffee; ground coffee beans; whole coffee beans; coffee-based iced beverages; roasted coffee beans; coffee substitute; beverages made of coffee or roasted coffee; coffee beans; coffee extracts; artificial coffee; powdered coffee in drip bags; tea-based iced beverages; iced tea; raw sugar; powdered sugar; sugar and sugar substitutes; white sugar; sugar-coated coffee beans; brown sugar; cubed sugar; granulated sugar; natural brown sugar;

sugar wafers; sugar substitutes; sugars; liquid coffee; cappuccino; cappuccino mixes; and coffee enhanced with nutrients.

2. Petitioner has filed U.S. Application for the trademark LET'S COFFEE (word mark) in Class 30. The U.S. Patent and Trademark Office (“PTO”) assigned Application Serial No. 98193781 to this application.

3. Registrant’s Mark was cited against the application for registration for Petitioner’s mark LET’S COFFEE.

4. On information and belief, Registrant is a Hawaii-based business having multiple location addresses in Hawaii, namely 208 Kapuni St. Honolulu, HI 96815, 67-292 Goodale Ave., Waialua, HI 96791 and 1909 Ala Wai Blvd, Honolulu, HI 96815.

5. Registrant is the record owner of invalid Registration No. 6195637 for the purported mark LET'S GRAB COFFEE for “coffee mugs” in International Class 21, “coffee” in International Class 30 and “coffee shops” in International Class 43.

6. Standing is satisfied because Petitioner has a real interest in the progression and registration of Petitioner’s Application for the LET'S COFFEE mark. Petitioner believes that it has been damaged or will sustain damages by the continued existence of Registrant’s trademark registration for LET'S GRAB COFFEE.

7. Petitioner alleges that Registrant’s Mark and the underlying registration has been abandoned for nonuse, and as alleged below, Petitioner respectfully requests that the registration be cancelled.

NON-USE OF REGISTRANT’S MARK (15 U.S.C. § 1051(a)(1))

8. Upon information and belief Registrant has ceased use of the Registered Mark in commerce.

9. Upon information and belief, as of June 30, 2024, the domain name for <https://www.brewandfoam.com/> has expired. As of this date, the domain name now redirects to a site unrelated to Registrant's business- a non- English language gaming site. (Exhibit A)

10. Upon information and belief, the coffee shop at locations 208 Kapuni St. Honolulu, HI 96815, 67-292 Goodale Ave., Waialua, HI 96791 and 1909 Ala Wai Blvd, Honolulu, HI 96815 are no longer open for business and the legal entity business was dissolved by the Hawaii Secretary of State on July 2, 2019. (Exhibit B)

11. Upon information and belief, the Facebook page for Registrant, <https://www.facebook.com/brewfoam/>, is no longer active. (Exhibit C)


