PETITION TO CANCEL

As grounds for the petition, Petitioner alleges as follows:

1. Petitioner is a California Corporation, having a mailing address at 1950 W Corporate Way, #29030, Anaheim, CA 92801, USA.
2. On November 17, 2024, Petitioner filed a trademark application for the mark OC PATENT LAWYER. The trademark application was assigned serial number 98857813 ('813 application).
3. Upon filing of this Petition to Cancel and after receiving an office action on the merits, Petitioner will request suspension of the prosecution of the '813 application.
4. On information and belief, the '384 Registration is owned by Mr. Matt Mushet (Registrant). A copy of the '384 Registration is attached hereto as Exhibit A.

5. On information and belief, Registrant is an individual residing at 6332 Royal Grove Drive, Huntington Beach, CA 92648, USA.

6. The '384 Registration lists the following services in International Class 45:
Intellectual property consultation.

7. The '384 Registration on its face claims that Registrant first used the mark OC PATENT in commerce on July 15, 2006.

8. On information and belief, Registrant has not used the mark in commerce since 2019.

9. Petitioner is damaged by the continued registration of the '384 Registration because the continued registration of the '384 Registration will prevent the registration of '813 Application.

10. Petitioner's grounds for this petition to cancel are 1) continued registration of the '384 Registration will prevent registration of Applicant's '813 application and 2) Registrant has abandoned use of the mark in commerce.

WHEREFORE, Petitioner requests that Registration No. 3263384 be cancelled.
