On December 15, 2011, applicant was allowed thirty days to provide additional facts to support its statement of abandonment of the mark by Parking Ticket Busters, Inc., to remove them as an excepted user from this proceeding, or to find a better address for Glenn Caldwell, registered agent for Parking Ticket Busters, Inc., New York so that he may be served on behalf of Parking Ticket Busters, Inc., New York.<sup>1</sup>

On January 12, 2012, applicant filed its response informing the Board that Parking Ticket Busters, Inc. has

not been in business since at least 1999, and its owner, Glenn Caldwell has not been offering legal services under the mark since at least 2006. Further, applicant states that there is no evidence of any intent by Mr. Caldwell to return to the business of offering legal services under a PARKING TICKET BUSTERS or similar mark particularly as his suspension from the practice of law continues. Applicant believes that this equates to an abandonment of the mark by Mr. Caldwell and PBT. Additionally, applicant asserts that per the website disclaimer of Ticket Busters, Inc., it also is not providing legal services and should be deleted from this concurrent use proceeding.

Accordingly, the Board finds the statement of facts sufficient to delete Parking Ticket Busters, Inc. and Ticket Busters, Inc. as excepted users in this proceeding.

In view thereof, this concurrent use proceeding is hereby dismissed as moot.

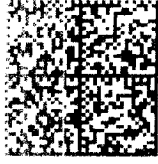
